## TERMS OF USE

### Terms and Conditions

We welcome you as a user of the services provided via the **IQSuite.cloud** Windows application, **BIOVAULT**, web-based application and/or mobile application (“**IQSuite.cloud**”). We are providing the services to you, subject to these **IQSuite.cloud** Personal Data Terms of Use and the **IQSuite.cloud** [Personal Data Privacy Policy](#) (collectively known as the “Terms”).
